NOTICE IS HEREBY GIVEN that the City of Newark Department of Water & Sewer Utilities will receive sealed bids on February 15, 2021 at 2:00 pm prevailing time at 920 Broad Street, Room #115, City Hall, Newark, New Jersey 07102, from vendors/chemical manufacturers for:

At such time, all bids will be publicly unsealed, and their contents will be read aloud. Bid solicitation packages will be available for pick up, free of charge, at City of Newark Water & Sewer Utilities, 920 Broad Street, Room B- 31F, City Hall, Newark, New Jersey 07102, during normal business hours. Prospective bidders will be required to submit a valid fax number where addenda can be sent.

NO BIDS WILL BE ACCEPTED AFTER THE BID OPENING HAS COMMENCED. Bids must be prepared and submitted using the standard Proposal Form that is provided in the bid document package. Each bidder shall submit one (1) original of their proposal, enclosed in a sealed envelope bearing the name of the bidder and clearly marked "CRANE MAINTENANCE AND REPAIR AT THE CITY OF NEWARK FACILITIES - Contract # 07-WS2022". Facsimile transmissions (faxes) will not be accepted.

Bids must be accompanied by a bid guarantee in the form of a certified check, bid bond or cashier's check in the amount of ten percent (10%) of the total amount bid, but not in excess of \$20,000.00, made payable to the order of the City of Newark. The guarantee of the successful bidder will be returned upon execution of the contract. All guarantees of the unsuccessful bidders will be returned upon award of contract to the successful bidder.

INSTRUCTIONS MUST BE FOLLOWED EXACTLY OR THE BID MAY BE DECLARED NON-RESPONSIVE. The right to reject any and all bids and to waive any informality in any bid is reserved if such an action is not detrimental to the interest of the City of

Newark.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. (P.L. 1975, c.127) and N.J.A.C. 17:27-1.1 et seq., concerning affirmative action, and any amendment thereto, and P.L. 1977, c. 33, which refers to the statement of corporation ownership.
