Sealed Bids will be received at 10:00AM prevailing time, on April 9, 2024 by the Department of Water Sewer Utility, City of Newark, at City Hall, 920 Broad Street, Newark, New Jersey, 1st floor in Room 115 Procurement and Budget Unit, and there publicly opened and read aloud for the following:

No bids will be received after the hour named. The City of Newark hereinafter called the "Owner" accepts no responsibility for any submittal of bids prior to their presentation at the date and hour indicated for the formal bid opening. Professional Consulting Inc. is defined as "Engineer" and representative of the Owner.

In general, the principal items of work under this Contract includes, but are not necessarily limited to, the following:

- A. Existing roof demolition and removal/replacement of all appurtenances at each location.
- B. Disposal of all waste materials in accordance with all Federal, State and local regulations.
- C. Install new roofing system
- D. All other related appurtenances and work.

Contract Documents may be examined and obtained at the Department of Water & Sewer Utilities, Division of Sewers and Water Supply, 1294 McBride Avenue, Little Falls, New Jersey 07424 during regular business hours. Copies of the Contract Documents may be obtained upon payment of a \$100.00 (one hundred dollars) nonrefundable fee made, with checks made payable to "The City of Newark". No documents will be mailed. At the time Contract Documents are purchased, Contractors shall also be required to furnish a valid fax number to which all addenda can be directed (if necessary).

Bidders will be furnished one set of Contract Documents for the deposit specified. Additional sets may be purchased for the deposit specified. No refunds will be given for the return of additional sets.

A non-mandatory pre-bid meeting and site visit will be

held at 10:00 AM, on March 25, 2024, at the
Little Falls Office, 1294 McBride Avenue, Little Falls, New
Jersey, 07424

Each Bid shall be submitted in accordance with the Instruc-
tions to Bidders and shall be accompanied by a Bid Security
in the form of a bid bond, cashier's check, or a certified
check made payable to the City of Newark in an amount
equal to ten percent (10%) of the amount of the total bid,
but not in excess of \$20,000.00.

No Bidder may withdraw his/her Bid for a period of sixty
(60) calendar days after the actual date of the opening of
the Bids, except for reasons covered under N.J.S.A. 40A:11-
23.3.

The Successful Bidder must furnish a 100 percent Perform-
ance Bond, and a 100 percent Payment Bond
with a surety company licensed in the State of New Jersey,
and meets the requirements of N.J.S.A. 2A:44-143. Surety
company shall also be listed on latest version of the U.S. De-
partment of Treasury Circular 570. Complete instructions
for filing Bids are included in the Instructions to Bidders. All
bidders must comply with N.J.S.A. 40A:11-1, as amended rel-
ative to submission of a certification of the bidder, indicat-
ing the ability to perform the Contract.

The bidder, in conformance with N.J.S.A. 52:25-24.2, shall
submit with its bid, a statement setting forth the names and
addresses of all stockholders who own a ten percent (10%)
or greater interest in the firm.

The successful bidder shall be required to comply with the
provisions of the New Jersey Prevailing Wage Act, N.J.S.A.
34:11-56.25 et seq. The successful bidder shall be required to
comply with Davis-Bacon prevailing wage requirements (40
U.S.C. § 3141 et seq. and 29 CFR Parts 5,6), and the higher of
the state or federal wages shall apply.

The Bid is subject to New Jersey Local Public Contracts Law
N.J.S.A. 40A:11-1 et. seq. Bidders must comply with N.J.S.A.
52:32.44 by providing a Business Registration Certificate pri-
or to contract award.

Pursuant to P.L. 2005, c.271, the "Pay to Play Legislation", a
Contractor shall file an annual disclosure statement on po-
litical contributions with the New Jersey Election Law En-
forcement commission pursuant to N.J.S.A. 19:44A-20.13 (P.L.
2005, c. 271, s. 3) if the contractor receives contracts in ex-
cess of \$50,000.00 from public entities in a calendar year.
The Contractor shall be responsible for determining if filing
is necessary. Additional information on this requirement is
available from ELEC at 888-313-3532 or at www.elec.state.nj.us.

All proposals are subject to the requirements of all laws and
City of Newark Ordinances affecting same. The bidder's at-
tention is directed to Sec. 2:4-14 of the City of Newark Ad-
ministrative Code. Bidders are also advised as to the applic-
ability of the City of Newark's Affirmative Action Program
and must, during the performance of the contract, comply
with the requirements of N.J.S.A. 10:5-31 et seq. and

N.J.A.C.17:27.

In addition, the Contractor must certify that at least 25% of the total Contract bid price will be directed and paid to a minority business enterprise, either through joint venture arrangement, partnerships, subcontractors, the purchase of goods and services or any other method available. The term "minority business enterprise" means a business at least fifty-one (51) percent of the stock of which is owned by a minority group member. "Minority group members" are citizens of the United States, who are Black, Hispanic, Asian American, Indians, Eskimos, and Aleuts. Successful bidders shall be required to attend a meeting with, and obtain clearance from, the City of Newark's Office of Affirmative Action prior to execution of the contract.

An additional seven percent (7%) of the total Contract bid price will be directed and paid to a woman's business enterprise, either through joint venture arrangements, partnerships, subcontractors, the purchase of goods and services or any other method available. The term "women's business enterprise" means a business where at least fifty-one (51) percent of the stock is owned by women.

The Owner reserves the right to reject all Bids in accordance with N.J.S.A. 40A:11-13.2 and waive minor informalities. The Contract will be awarded to the lowest responsible and responsive bidder, in accordance with applicable law.
